

## Wyoming & U.S. Energy

"Wyoming has the smallest population of any state but supplies more energy to the rest of the nation than any other state." EIA (12/2016)

- Energy-related mining & extraction: WY's biggest industry
  - Located in 22 out of 23 WY counties (PAW 2015)
  - Backbone of state's revenues



## Wyoming & U.S. Energy

#### WY produces:

- Coal 42% of U.S. coal (8 of 10 largest mines in WY)
- Natural gas in top 10 U.S. producers
- Oil 2-3% of U.S. crude oil
  - WY has more producing federal O&G leases than any other state
- Electricity 66% exported (largely coal-fired)
- Wind in top 10(largest wind project in U.S.)
- Solar 46<sup>th</sup> in U.S.

### Where Were We?

#### **Climate Change Driver for Obama Energy Policy**

- Climate Action Plan/Paris (2015)
- Clean Power Plan: Shift power from coal to renewables/natural gas
  - WY hit hard under the CPP
- Regulate existing & new sources of CO₂ & methane
- Raise CAFE standards
- Encourage renewable energy
- Regulate federal O&G and coal development

### Where Were We: Interior?

- 2010 O&G Leasing Reform (IM-2010-117)
  - Fewer parcels & sales
- 2015 Fracking Rule [80 FR 16128 (3/26/15)]
  - Enjoined by WY Court, on appeal 10<sup>th</sup> Cir.



- 2016 Venting & Flaring Rule [81 FR 83008 (11/18/16)]
- 2016 Onshore Orders (O&G measurement)
  - No. 3 [81 FR 81356 (11/17/16)]
  - No. 4 [81 FR 81462 (11/17/16)]
  - No. 5 [81 FR 81516 (11/17/16)]

- Final Plan Minor Source Rule Indian County (2016)

- "Refocus" EPA to protect air & water





- Presidential Memorandum on Construction of Keystone XL [82 FR 8663 (1/24/17)]
  - Application approved March 23, 2017




Pipeline ROW issued February, constructed March, operating May

  - ONNR "paused"/began repeal of royalty valuation rule [82 FR 11823 (2/27/17);
     82 FR 16325 & 16323 (4/4/17)]
    - Reestablished Royalty Policy Committee [82 FR 16222 (4/3/17)]
  - Secretarial Order No. 3348 (3/24/17) BLM Coal Moratorium & PEIS stopped, revoked Secretarial Order No. 3338 (1/15/16)
  - BLM to "revisit" planning processes (3/27/17)
  - Secretarial Order No. 3352 (5/31/17) new NPRA plan/plan to assess NPRA/ANWR

#### **EPA**

    - Abeyance Am. Petroleum Inst. v. EPA, No. 13-1108 (D.C. Cir. May 18, 2017)
  - Reevaluation of Clean Power Plan (3/28/17)
    - Abeyance of litigation while EPA reconsiders CPP rule West Virginia v. EPA, No. 15-1363 (D.C. Cir. Apr 28, 2017) & North Dakota v. EPA, No. 15-1381 (D.C. Cir. April 28, 2017)

#### **Trump Pulls Out of Paris Agreement (6/2/17)**

"The Paris Climate Accord is simply the latest example of ... an agreement that disadvantages the U.S. to the exclusive benefit of other countries ... Thus, as of today, the U.S. will cease all implementation of the non-binding Paris Accord ..."



## **Congress Helps Change Direction**

#### Congressional Review Act, 5 USC §§ 801-808 (1996)

- Signed into law by Clinton
- Used once before (to disapprove Clinton rule)
- 60 legislative days to review/"disapprove" new rules
  - "time's up" May 10, 2017
- Simple majority vote
- Once gone, "no substantially similar rule"
- No judicial review
- Congress used 14 times to roll back
   Obama rules



## Congress Helps Change Direction

- CRA Actions to "disapprove" energy/environmental rules signed into law:
  - SEC disclosure rules for resource extraction (HRJ Res. 41)
  - OSM Stream Protection Rule (HJR Res. 38)
  - BLM Planning 2.0 (HJR Res. 44)
  - FWS hunting in Alaska Refuges (HJR Res. 69)
- The CRA that got away BLM venting/flaring rule (HJR Res. 36)
  - Failed to pass (5/10/17)




### **Congress Helps Change Direction**

- What failed methane CRA means:
  - BLM venting/flaring rule compliance deadline: Jan. 1, 2018
    - Companies need to prepare now with leak detection/repair
  - Rule in litigation in WY
  - BLM intends to review/rescind Press Release (5/10/17)
  - APA requirements to rescind/suspend take time
- CRA litigation: Center for Biological Diversity v. Zinke, No. 3:17-cv-00091 (D. Alaska filed 4/20/17)
  - Constitutional separation of powers challenge to CRA disapproval of FWS Alaska refuge hunting rule

#### **Big Picture of \$4.1 Trillion Budget**

- Budget goal: deficit cutting
  - Balanced in 10 years
- Budget cuts non-defense discretionary spending by \$1.6T
  - US EPA cut 30%
  - DOI cut 11%
  - DOE cut 6%
- Budget protects Social Security/Medicare
   (2 biggest drivers of deficit)
- Budget increases:
  - DOD 10%
  - Infrastructure (\$1T) & border wall (\$2.6B)
- How?
  - Predicts 3% growth
  - 2% cuts for 10 years



#### **Energy/Public Lands Impacts**

- Reverse Obama Climate Change Policies EPA budget for climate change "waste of your money" (OMB, Mulvaney)
  - Discontinue CPP, climate research
  - CAA programs cut 24%
  - EPA enforcement down 24%
  - NOAA climate research down 16%
  - USGS climate research down \$160 M
  - DOE, EERE down 69%
  - DOE, Fossil Energy down 56%
  - DOE, Nuclear down 31%
  - DOI Renewable Energy budget cut on/off-shore



- Cut Federal/Grants to States
  - EPA CAA/CWA, SDWA grants down 45%
  - Eliminate 37% revenue sharing for off-shore O&G
  - Eliminate geothermal revenue-sharing
  - Eliminate AML land grants/reduce AML payments
  - Cut \$16 million for economic development in coal country
  - Decrease PILT




- Land Acquisition/Conservation
  - Land acquisition "lower priority" cut \$129M
  - LWCF down to \$51M from \$189M
  - BLM GSG "Implementation Strategy" down 17%
  - FWS science support/cooperative landscape conservation "zeroed out"
  - NLCS cut \$9M
- Federal Fossil Fuel as Revenue Raiser
  - Increase offshore O&G budget \$1.1B
  - Increase BLM O&G permitting \$16M (\$1.1B total BLM budget)
  - Drill in ANWR (raise \$1.8B)
  - Lease on-shore O&G to raise \$36B over 10 yrs.
  - Sell off 50% of Strategic Petroleum Reserve (+ \$16.5B)

# Personnel Is Policy Who's Who on Energy?

- EPA: Oklahoma Attorney General Scott Pruitt
  - "I believe that we as a nation can both be pro-energy and jobs, and pro-environment. We don't have to choose between the two." (2017)

- What he did before: Sue EPA
- Interior: Representative Ryan Zinke (R-MT)
  - "I have absolutely and unequivocally opposed any attempts to transfer, sell, or privatize our public lands." (2017)
  - What he did before: Navy Seal
- DOE: Texas Governor Rick Perry
  - "My past statements about abolishing the Department of Energy do not reflect my current thinking. In fact, after being briefed on so many of the vital functions . . . I regret recommending its elimination." (2017)
  - What he did before: Ran for President in 2012

441 no nominee

15 await confirmation 64 formally nominated

39 confirmed

- DOI 17 positions: 1 confirmed (1 nominated)
- USDA 13 positions: 1 confirmed
- DOE 22 positions: 1 confirmed (2 nominated)
- DOJ 28 positions: 3 confirmed (4 nominated)

Chair Senate Energy, Senator Murkowski: "Well, here we are,
Tuesday, June 6. Outside of Secretary Perry and Secretary Zinke, these
are the only four that we've had come before our committee ... I
don't think that's an acceptable pace. Just saying."
